Abstract

In an incomplete market there are many equivalent martingale measures and many ways of pricing options. In this talk we shall review some of these methods, with special emphasis on option pricing in stochastic volatility models, which may be viewed as the prototypical incomplete market. In particular we shall be interested in comparing the different pricing mechanisms and the resulting option prices.
