

Arbitrage in Diverse Markets

Abstract

We consider a diverse financial market, i.e. there exists a (small) $c > 0$ such that no stock can have a market weight which is larger than $1 - c$. By a change of measure technique we can give a simple proof that the market allows for arbitrage for every time horizon $T > 0$.
