

Portfolio decisions in incomplete markets

Abstract

We study the optimal portfolio decisions of a risk averse individual in an incomplete market environment. Risk preferences are taken to be of exponential or of power type. Using elements from the utility-based valuation theory, we characterize the optimal investment strategies and discuss their behavior in terms of various market parameters and levels of incompleteness.
